### Description

Unit 1 is an End-terrace single-storey Factory/ Warehouse with two storey integral Offices to the front. The unit is due to be fully refurbished, to include full decoration throughout and new floor coverings to the Offices. Internally, the property benefits from a mixture of Private and Open-Plan Offices, with suspended ceilings incorporating inset fluorescent lighting. The Gross Internal Area (GIA) extends to approxmiately 11,954 sq ft (1,110.5 sq m). The unit benefits from a minimum working height of 18'10" (5.75 m). Externally, the unit benefits from a gated, concrete-surfaced Yard, providing access to a loading door to the rear. Communal parking is provided within the Estate.

#### Location

Colemeadow Industrial Estate is recognised as arguably the most prestigious of the industrial locations in Redditch. Junction 3 of the M42 is four miles to the north via the A435, bringing the M40 interchange within 10 minutes drive and links to the M5, M6 and M69.

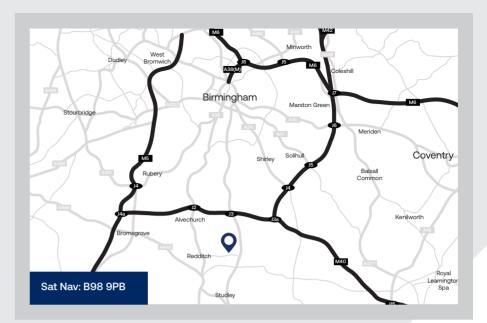
