## Description

New to the market industrial warehouses available 6,975 – 41,850sq ft individually or combined. The estate has benefited from a recent external refurbishment and the landlords intention is to provide a full internal refurbishment of each warehouse inclusive of a new roof system. The estate has a generous supply of parking and each unit benefits from a dedicated yard to the front. Access to the buildings is via electronically operated roller shutter doors. The warehouses are of steel-portal frame construction and have an eaves height of 5.3m.

#### Location

The industrial estate is located on Sandwell Business Park, off Crystal Drive, in the Smethwick area of Birmingham. Crystal Drive connects directly to the A4254 Telford Way/Kendrick Way. Motorway access is provided at Junction 1 of the M5 less than two miles to the north east. West Bromwich town centre lies approximately 1½ miles to the north and Birmingham city centre approximately 6 miles to the east.


